	Introduction Scope of this ISA
ISA 200.1	1. This purpose of this International Standard on Auditing (ISA) is to establish the independent auditor's overall responsibilities when conducting standards and provide guidance on the objective and general principles governing an audit of financial statements in accordance with ISAs. It also describes management's responsibility for the preparation and presentation of the financial statements and for identifying the financial reporting framework to be used in preparing the financial statements, referred to in the ISAs as the "applicable financial reporting framework."
Preface 10	2. ISAs are written in the context of an audit of financial statements by an independent auditor. They are to be adapted as necessary in the circumstances when applied to audits of other historical financial information.

Preface 11.1 ² & ISA 200.2	4. The objective of an audit of financial statements is to enable the auditor to express an opinion whether the financial statements are prepared, in all material respects, in accordance with an applicable financial reporting framework.
Preface 12.1	5. In conducting an audit <u>so as to achieve its objective</u> , the overall objective of the auditor is to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to report on the financial statements in accordance with the auditor's findings.
Preface 12.2	6. <u>The objective of an audit cannot be fulfilled unless the auditor achieves the overall objective of the auditor.</u> In all cases when the overall objective of the auditor has not been or cannot be achieved, the ISAs require that the auditor modifies the auditor's opinion accordingly or withdraws from the engagement.
	7. <u>Reasonable assurance is the level of assurance required by the ISAs, which are</u>

Glossary	(b) Audit evidence – All of the information used by the auditor in arriving at the conclusions on which the audit opinion is based. Audit evidence includes the information contained in the accounting records underlying the financial statements and other information.
ISA 200.23.3	(c) Audit risk – The risk that the auditor expresses an inappropriate audit opinion when the financial statements are materially misstated is known as “audit risk”.
ISA 200.31.1 & 31.2	(d) Detection risk – The risk that the <u>procedures performed by the auditor to reduce audit risk to an acceptably low level</u> will not detect a misstatement that exists in an assertion <u>and</u> that could be material, either individually or when aggregated with other misstatements.

The term ordinarily refers to a complete set of financial statements, but it can also refer to a single financial statement, for example, a balance sheet, or a statement of revenues and expenses, and related explanatory notes.

<p>ISA 200.3</p>	<p>A1. An audit of financial statements is an assurance engagement, as defined in the International Framework for Assurance Engagements. The Framework defines and describes the elements and objectives of an assurance engagement. The ISAs apply the Framework in the context of an audit of financial statements and contain the basic principles and essential procedures, together with related guidance, to be applied in such an audit. Paragraphs 34-35 in this ISA discuss the meaning of the term "financial statements" and management's responsibility for such statements. As discussed in the Framework, a condition for acceptance of an assurance engagement is that the criteria referred to in the definition are "suitable criteria"</p>

Paragraphs 37-48 in this ISA discuss suitable criteria and their availability to intended users for an audit of financial statements through the auditor's consideration of the acceptability of the financial reporting framework. The financial statements are prepared by the management of the entity, with oversight from those charged with governance.</p> <p><u>The auditor is engaged for purposes of expressing an opinion. It is undertaken designed to enhance the degree of confidence of intended users in the financial statements about whether the financial statements are prepared, in all material respects, in accordance with an applicable financial reporting framework. The objective of an audit, therefore, is to enable the auditor to express that opinion.</u></p>
	<p>A2. <u>The overall objective of the auditor restates the objective of an audit in a way that can more readily be related to the objectives and requirements of the ISAs. For the financial statements to be prepared, in all material respects, in accordance with an applicable financial reporting framework, they must be free from material misstatement. The overall objective of the auditor reflects the fact that the basis for the auditor's opinion is reasonable assurance. The auditor obtains reasonable assurance by reducing audit risk to an acceptably low level, through accumulating and evaluating sufficient appropriate audit evidence. The auditor's opinion on the financial statements is expressed in a written report.</u></p>

<p>ISA 200.33</p>	<p>A3. <u>The concept of an audit by an independent auditor is premised on the fact that the financial statements subject to audit are those of the entity, prepared and presented by management of the entity with oversight from those charged with governance, with the auditor engaged for purposes of forming and expressing an opinion on them. While the auditor is responsible for forming and expressing an opinion on the financial statements, the responsibility for the preparation and presentation of the financial statements in accordance with the applicable financial reporting framework is that of the management of the entity, with oversight from those charged with governance. The audit of the financial statements does not relieve management or and those charged with governance of their responsibilities. The auditor is also entitled to expect that management and those charged with governance will make available to the auditor all the information the auditor requires for the purposes of the audit.</u></p>

Other sources may provide direction on the application of the applicable financial reporting framework. Although the framework may not specify how to account for or disclose all transactions or events, it ordinarily embodies sufficient broad principles that can serve as a basis for developing and applying accounting policies that are consistent with the concepts underlying the requirements of the framework.

ISA 800 Conf. Amndts	A10. The requirements of the applicable financial reporting framework also determine what constitutes a complete set of financial statements. In the case of many frameworks, financial statements are intended to provide information about the financial position, financial performance and cash flows of an entity. For such frameworks, a complete set of financial statements would include a balance sheet; an income statement; a statement of changes in equity; a cash flow statement; and related explanatory notes, comprising a summary of significant accounting policies and other explanatory notes. For some other financial reporting frameworks, a single financial statement and the related explanatory notes might constitute a complete set of financial statements. For example, the International Public Sector Accounting Standard (IPSAS), “Financial Reporting Under the Cash Basis of Accounting” states that the primary financial statement is a statement of cash receipts and payments when a public sector entity prepares and presents its financial statements in accordance with that IPSAS.

Amndts	A11. <u>[Proposed] ISA 210 (Redrafted), “Terms of Audit Engagements” establishes requirements and provides guidance</u> contains standards and guidance on determining the acceptability of the applicable financial reporting framework. ISA 800 (Revised), “Special Considerations—Audits of Special Purpose Financial Statements and Specific Elements, Accounts or Items of a Financial Statement” contains additional considerations for special purpose frameworks.
	<i>Materiality</i> (Ref: Para. 8(b))
ISA 240.2.1 ISA 200.26.1 and .2 Derived from ED ISA 320.2 and .5	A12. Misstatements in the financial statements can arise from either fraud or error. The auditor is <u>responsible for obtaining reasonable assurance about whether the financial statements as a whole are free from concerned with</u> material misstatements, <u>but</u> and is not responsible for the detection of misstatements that are not material to the financial statements taken as a whole. The auditor considers whether the effect of identified uncorrected misstatements, both individually and in the aggregate, is material to the financial statements taken as a whole. Materiality and audit risk are related (see ISA 320, “Audit Materiality”). <u>In general, misstatements, including omissions, are considered to be material if they, individually or in the aggregate, could reasonably be expected to influence the economic decisions of users taken on the basis of the financial statements. The concept of materiality is used both in planning and performing the audit, and in evaluating the effect of identified misstatements on the financial statements and the related auditor’s report, as discussed further in [proposed] ISA 320 (Revised and Redrafted), “Materiality in Planning and Performing an Audit” and [proposed] ISA 450 (Revised and Redrafted), “Evaluation of Misstatements Identified during the Audit,” respectively.</u>

	<i>Audit Risk</i> (Ref: Para. 8(c))
ISA 200.25.1	A13. <u>Audit risk is the risk that the auditor expresses an inappropriate audit opinion when the financial statements are materially misstated. This Audit-risk is a function of the risks of material misstatement of the financial statements (or simply, the “risk of material misstatement”) (i.e., the risk that the financial statements are materially misstated prior to audit) and the risk that the auditor will not detect such misstatement (“detection risk”).</u>
ISA 200.30.2	<u>The auditor is required to assess the risk of material misstatement at the assertion level as a basis for further audit procedures, though that a</u> Assessment of risks is a judgment; rather than a precise measurement of risk. <u>Reasonable assurance is obtained by reducing audit risk to an acceptably low level, through accumulating and evaluating sufficient appropriate audit evidence.</u>
	Risks of Material Misstatement
ISA 200.26.4 onward	A14. In order to design audit procedures to determine whether there are misstatements that are material to the financial statements taken as a whole, the auditor considers <u>The risks of material misstatement may exist at two levels: at the overall financial statement level, and, in relation to classes of transactions, account balances, and disclosures, at and the related assertions level.</u>
ISA 200.27	A15. The auditor considers the <u>Risks of material misstatement at the overall financial statement level, which refers to risks of material misstatement that relate pervasively to the financial statements as a whole and potentially affect many assertions. Risks of this nature often relate to the entity’s control environment (although these risks may also relate to other factors, such as declining economic conditions), and are not necessarily risks identifiable with specific assertions at the class of transactions, account balance, or disclosure level. Rather, this overall risk represents circumstances that increase the risk that there could be material misstatements in any number of different assertions, for example, through management override of internal control. Such risks may be especially relevant to the auditor’s consideration of the risk of material misstatement arising from fraud. The auditor’s response to the assessed risk of material misstatement at the overall financial statement level includes consideration of the knowledge, skill, and ability of personnel assigned significant engagement responsibilities, including whether to involve experts; the appropriate levels of supervision; and whether there are events or conditions that may cast significant doubt on the entity’s ability to continue as a going concern.</u>
ISA 200.28	A16. The auditor also considers the <u>Risks of material misstatement at the class of transactions, account balance, and disclosure level need to be assessed in order to because such consideration directly assists in determining the nature, timing, and extent of further audit procedures at the assertion level necessary.</u> The auditor seeks to obtain sufficient appropriate audit evidence at the class of transactions,

These latter factors include, for example, a lack of sufficient working capital to continue operations or a declining industry characterized by a large number of business failures.

Control <u>That</u> risk is a function of the effectiveness of the design and operation of internal control in achieving the entity's objectives relevant to preparation of the entity's financial statements. Some control risk will always exist because of the inherent limitations of internal control.

When the auditor's assessment of the risk of material misstatement includes an expectation of the operating effectiveness of controls, the auditor performs tests of controls to support the risk assessment. The ISAs do not ordinarily refer to inherent risk and control risk separately, but rather to a combined assessment of the "risks of material misstatement." Although the ISAs ordinarily describe a combined assessment of the risk of material misstatement <u>However,</u> the auditor may make separate or combined assessments of inherent and control risk depending on preferred audit techniques or methodologies and practical considerations. The assessment of the risk of material misstatement may be expressed in quantitative terms, such as in percentages, or in non-quantitative terms. In any case, the need for the auditor to make appropriate risk assessments is more important than the

	different approaches by which they may be made.
	Detection Risk

It may also contain introductory material that provides context essential to a proper understanding of the ISAs, and definitions.
Preface 19 Preface 29.2	A57. The application and other explanatory material is an integral part of the ISA, as it provides further explanation of, and guidance for carrying out, the requirements of an ISA, along with background information on the matters addressed in the ISA. It may include examples of procedures, some of which the auditor may judge to be appropriate in the circumstances. Such guidance is, however, not intended to impose a requirement. –When appropriate, additional considerations specific to <u>audits of smaller entities and public sector entities are included:</u> (a) W <u>within the application and other explanatory material</u> body of an International Standard in the case of ISAs and ISQCs, or (b) In a Public Sector Perspective (PSP) appearing at the end of other International Standards.
Preface 20	A58. Appendices, which form part of the application and other explanatory material, are an integral part of an ISA. The purpose and intended use of an appendix are explained in the body of the related ISA or within the title and introduction of the appendix itself.
Preface 21	A59. Introductory material may include, as needed, such matters as explanation of: <ul style="list-style-type: none"> • <u>T</u>the purpose and scope of the ISA, including how the ISA relates to other ISAs; • <u>T</u>the subject matter of the ISA;

	<ul style="list-style-type: none"> • <u>S</u>specific expectations on the auditor and others; and • <u>T</u>he context in which the ISA is set.
Preface 22	A60. An ISA may include, in a separate section under the heading ‘Definitions’, a description of the meanings attributed to certain terms for purposes of the ISAs. These are provided to assist in the consistent application and interpretation of the ISAs, and are not intended to override definitions that may be established for other purposes, whether in law, regulation or otherwise. Unless otherwise indicated, those terms will carry the same meanings throughout the ISAs. The Glossary of Terms in the Handbook of International Auditing, Assurance, and Ethics Pronouncements published by IFAC contains a complete listing of terms defined in the ISAs. It also includes description of other terms found in ISAs to assist in common and consistent interpretation and translation.
	<i>Objectives</i> (Ref: Para. 16)
	<p>A61. <u>The objectives in individual ISAs provide a link between the requirements and the overall objective of the auditor. The objectives are designed to focus the auditor on the desired outcome of the ISA, while being specific enough to assist the auditor in:</u></p> <ul style="list-style-type: none"> • <u>Understanding what needs to be accomplished and, where necessary, the appropriate means of doing so; and</u> • <u>Deciding what more, if anything, needs to be done to achieve the objectives.</u>
	<p>A62. <u>The auditor’s ability to achieve the objectives is subject to the inherent limitations of an audit, and is to be understood in the context of those limitations as well as the other concepts relevant to an audit of financial statements set out in paragraph 8 of this ISA. Further, the ability to achieve an individual objective may be limited by circumstances; for example, by a limitation in the available audit evidence. The obligation attaching to the objectives therefore recognizes the fact that the achievement of an objective cannot be mandated, only the attempt to achieve it. The requirement to aim to achieve the objectives is reinforced by:</u></p> <ul style="list-style-type: none"> • <u>The requirement to comply with the requirements of ISAs (paragraph 18);</u> • <u>The requirement to obtain sufficient appropriate audit evidence as a basis for reasonable assurance (paragraph 19);</u> • <u>The requirement to use the objectives to judge whether, having complied with the requirements of the ISAs, sufficient appropriate audit evidence has been obtained (paragraph 20); and</u> • <u>The requirement to consider the consequences of a failure to achieve an objective (paragraph 16).</u> <p><u>—Whether an objective has been, or can be, achieved is a matter for the auditor’s professional judgment, including whether further procedures will assist the auditor</u></p>

	<u>in doing so.</u>
	<p>A63. <u>In aiming to achieve the objectives of the ISAs, the auditor is required to have regard to the interrelationships among the ISAs. This is because of the different nature of the ISAs, which as indicated in paragraph A51 deal in some cases with general responsibilities and in others with the application of those responsibilities to specific topics. For example, this ISA requires the auditor to adopt an attitude of professional skepticism; this is necessary in all aspects of planning and performing an audit but is not repeated as a requirement of each ISA. At a more detailed level, ISA 315 (Redrafted), “Identifying and Assessing the Risks of Material Misstatement Through Understanding the Entity and Its Environment” and ISA 330 (Redrafted), “The Auditor’s Responses to Assessed Risks” contain, amongst other things, objectives and requirements that deal with the auditor’s responsibilities to identify and assess the risks of material misstatement and to design and perform further audit procedures to respond to those assessed risks, respectively; these objectives and requirements apply throughout the audit. An ISA dealing with specific aspects of the audit (for example, [proposed] ISA 540 (Revised and Redrafted), “Auditing Accounting Estimates, Including Fair Value Accounting Estimates, and Related Disclosures”) may expand on how the objectives and requirements of such ISAs as 315 (Redrafted) and 330 (Redrafted) are to be applied in relation to the subject of the ISA but does not repeat them. Thus, in aiming to achieve the objective stated in ISA 540 (Revised and Redrafted), for example, the auditor has regard to the objectives and requirements of other relevant ISAs.</u></p>
	<p>A64. <u>In most cases, the objectives of the ISAs are clearly related to the overall objective of the auditor. The majority of the ISAs deal with one or more of the following:</u></p> <ul style="list-style-type: none"> • <u>Identifying, assessing and responding to risks of material misstatement;</u> • <u>Obtaining sufficient appropriate audit evidence, either in relation to specific aspects of the evidence accumulation process (e.g., audit sampling, in relation to obtaining sufficient evidence) or in relation to specific subjects (e.g., accounting estimates);</u> • <u>Evaluating the effect of identified misstatements on the financial statements; and</u> • <u>Reporting.</u> <p><u>Accordingly, the failure to achieve those objectives would prevent the auditor from achieving the auditor’s overall objective.</u></p>
	<p>A65. <u>In a few cases, however, the relationship between the objectives of the ISAs and the overall objective of the auditor is indirect. This is the case, for example, with the ISAs that deal with quality control and documentation. Such ISAs are intended to enhance the quality of the audit and to ensure that, in the public interest, the auditor maintains an appropriate record of the basis for the auditor’s report. In</u></p>

	<u>principle, an auditor could fail to achieve the objectives of such ISAs while nevertheless obtaining reasonable assurance and forming an appropriate opinion about the financial statements. There would, however, be a substantial risk that this would not be the case. In any event, the auditor would not have complied with all ISAs relevant to the audit; accordingly, in accordance with paragraph 14 of this ISA, the auditor could not represent compliance with ISAs, as required to do under the reporting ISAs.</u>
	A66. <u>The auditor may fail to achieve the overall objective of the auditor through being unable to obtain reasonable assurance or through being unable to report. The ISAs deal with these circumstances and include appropriate requirements and guidance for the auditor.</u>
	Compliance with Relevant Requirements (Ref: Para. 18(a))
Preface 17	A67. The auditor <u>is required to comply</u> ies with the requirements of an ISA in all cases where they are relevant in the circumstances of the audit. In exceptional circumstances, however, the auditor may judge it necessary to depart from a relevant requirement by performing alternative audit procedures to achieve the aim of that requirement. The need for the auditor to depart from a relevant requirement is expected to arise only where the requirement is for a specific procedure to be performed and, in the specific circumstances of the audit, that procedure would be ineffective. In such circumstances, alternative audit procedures need to be performed that achieve the aim of that requirement. <u>ISA 230 (Redrafted), “Audit Documentation” establishes documentation requirements in those circumstances where the auditor departs from a requirement.</u>
Preface 18.1 (examples are from extant ISA 230)	A68. A requirement is not relevant only in the cases where: (a) The ISA is not relevant(e.g., <u>in a continuing engagement, nothing in ISA 510, “Initial Engagements—Opening Balances,” is relevant</u>); or (b) The circumstances envisioned do not apply because the requirement is conditional and the condition does not exist. <u>In general, any conditionality of a requirement will be explicit (e.g., the requirement to modify the auditor’s opinion where there is a limitation of scope). In some cases, it may be implicit (e.g., the communication of material weaknesses in internal control identified during the audit to management and with those charged with governance, which depends on the existence of identified material weaknesses).</u>
Preface 18.2	A69. The auditor is not required to apply a requirement that is not relevant in the circumstances of the audit; this does not constitute a departure from the requirement.
	<i>Obtaining Sufficient Appropriate Audit Evidence</i> (Ref: Para. 20)
	A70. <u>The auditor is required to use the objectives to judge whether sufficient appropriate</u>

	<p><u>audit evidence has been obtained. If as a result the auditor concludes that the audit evidence is not sufficient and appropriate, then the auditor may follow one or more of the following approaches to meeting the requirement of paragraph 19:</u></p> <ul style="list-style-type: none"><u>• Evaluate whether further relevant audit evidence has been, or will be, obtained as a result of complying with other ISAs;</u><u>• Extend the work performed in applying one or more requirements; or</u><u>• Perform other procedures judged by the auditor to be necessary in the circumstances.</u> <p><u>Where none of the above is expected to be practical or possible in the circumstances, the auditor will not be able to obtain sufficient appropriate audit evidence and is required to determine the effect on the audit report or on the auditor's ability to complete the engagement.</u></p>
