Specific Questions

Applicability of ED-5000 and the Relationship with ISAE 3410

3. Is the scope and applicability of ED-5000 clear, including when ISAE 3410 should be applied rather than ED-5000? If not, how could the scope be made clearer?

ISSA 5000 applies to assurance engagements over sustainability reporting, while ISAE 3410 for assurance engagements over greenhouse gas statements. However, it is unlikely that reporting entity to be limited to only sustainability information, or only a greenhouse gas statement. In the future, there will be one or more documents comprising a mix of historical financial information and sustainability information. Practitioners may be asked to assure multiple elements of an entity's reporting, which may necessitate the

application of more than one assurance standard. If the practitioner is engaged to provide several conclusions on aspects of topics presented in the sustainability report, including a conclusion on the greenhouse gas statement, it would seem necessary to apply ISAE 3410 with respect to the assurance conclusion to be expressed on the greenhouse gas statement, and ISSA 5000 with respect to all other assurance conclusions to be expressed on the remainder of the sustainability information. Further clarification seems warranted on multi-scope (“multi-conclusion”) engagements.

Relevant Ethical Requirements and Quality Management Standards

4. Is ED-5000 sufficiently clear about the concept of “at least as demanding” as the IESBA Code regarding relevant ethical requirements for assurance engagements, and ISQM 1 regarding a firm’s responsibility for its system of quality management? If not, what suggestions do you have for additional application material to make it clearer?

In Indonesia, the public accountant law currently clearly regulates that Assurance services using the standard issued by IAPI can only be performed by licensed Public Accountants complying with the Accountants Code of Ethics and Quality Management Standards as adopted from ISQM. The principle around the concept of “at least as demanding” as the IESBA Code regarding relevant ethical requirements for assurance engagements, and ISQM 1 regarding a firm’s responsibility for its system of quality management is clear. While the application material to the requirements explains in a reasonable level of detail on the matters addressed by the IESBA Code and, at a much higher level, for ISQM 1, the standard has not provided a further guidance or examples on how a practitioner will assess equivalence. This will be an area of significant professional judgement by practitioners in firms that are not required to comply with the IESBA Code or ISQM 1. This will also be an important area for policy makers in each jurisdiction to make a rule regarding the principle of “at least as demanding” on the code of ethics and quality management standards as described above in order to ensure that the assurance practitioners who will be providing sustainability assurance engagements are in the same playing field.

Using the Work of Practitioner's Experts or Other Practitioners

The standard is clear that when the practitioner who uses the work of a firm other than the practitioner's firm(s) is able to be sufficiently involved (direct, supervise and review) in the work of practitioners from other firm(s), then the individuals from other firm(s) who are performing the work are deemed to be part of the engagement team. When the engagement team cannot be sufficiently involved in the work of practitioner from other firm(s), the nature, timing and extent of procedures undertaken to evaluate the work of those practitioners are likely to be an area of potential inconsistency.

15. Are the requirements in ED-5000 for using the work of a practitioner's external expert or another practitioner clear and capable of consistent implementation? If not, how could the requirements be made clearer?
