This template is for providing comments on the Exposure Draft of proposed International Standard on Sustainability Assurance EngagementsTM (ISSA) 5000, *General Requirements for Sustainability Assurance Engagements* (ED-5000), in response to the questions set out in the Explanatory Memorandum to ED-5000. It also allows for respondent details, demographics and other comments to be provided. Use of the template will facilitate the IAASB's automated collation of the responses.

You may respond to all questions or only selected questions.

To assist our consideration of your comments, please:

- For each question, start by indicating your overall response using the drop-down menu under each question. Then below that include any detailed comments, as indicated.
- When providing comments:
 - Respond directly to the questions.
 - Provide the rationale for your answers. If you disagree with the proposals in ED-5000, please provide specific reasons for your disagreement and specific suggestions for changes that may be needed to the requirements, application material or appendices. If you agree with the proposals, it will be helpful for the IAASB to be made aware of this view.

Detailed comments (if any): Due to the complexity of the areas to be covered by the standards and the varying nature of the standards, it would be challenging to accommodate all the areas covered in the explanatory memorandum. It may also be difficult to enforce the standard on practitioners who are not members of the professional accountancy body.

2. Do you agree that the proposals in ED-5000 are responsive to the public interest, considering the qualitative standard-setting characteristics and standard-setting action in the project proposal? If not, why not?

Specific Questions

Applicability of ED-5000 and the Relationship with ISAE 3410

3. Is the scope and applicability of ED-5000 clear, including when ISAE 3410 should be applied rather than ED-5000? If not, how could the scope be made clearer?

Overall response: Yes, with comments below

Detailed comments (if any): We suggest that ISAE 3410 be updated by including new provisions from the exposure draft ED-5000. ISAE 3410 has been in use by the practitioners and are familiar with. The use of single standard, instead of two with similar objectives, may help the practitioners to easily understand the standard.

Relevant Ethical Requirements and Quality Management Standards

4. Is ED-5000 sufficiently clear about the concept of "at least as demanding" as the IESBA Code regarding relevant ethical requirements for assurance engagements, and ISQM 1 regarding a firm's responsibility for its system of quality management? If not, what suggestions do you have for additional application material to make it clearer?

Overall response: Yes, with comments below

Detailed comments (if any): The concept of "at least as demanding" is confusing and may be open to different interpretations. There could also be jurisdictional differences as far as IESBA Code and ISQM 1 are concerned with different requirements. We suggest additional guidance be provided by the Board in this respect.

Definitions of Sustainability Information and Sustainability Matters

5. Do you support the definitions of sustainability information and sustainability matters in ED-5000? If not, what suggestions do you have to make the definitions clearer?

Overall response: Yes, with comments below

Detailed comments (if any):We suggest the use of already familiar phrases "subject matter information" and "underlying subject matter" instead of using "sustainability information" and "sustainability matters" respectively in ED-5000.

6. Is the relationship between sustainability matters, sustainability information and disclosures clear? If not, what suggestions do you have for making it clearer?

Overall response: Yes (with no further comments)

Detailed comments (if any):

Differentiation of Limited Assurance and Reasonable Assurance

7. Does ED-5000 provide an appropriate basis for performing both limited assurance and reasonable assurance engagements by appropriately addressing and differentiating the work effort between limited and reasonable assurance for relevant elements of the assurance engagement? If not, what do you propose and why?

Overall response: Yes, with comments below

Detailed comments (if any): The difference between limited and reasonable assurance engagements is not clear. What drives to conduct limited assurance engagements or reasonable assurance engagements? What kind of evidence the practitioner will gather when he decides to perform limited assurance engagements or reasonable assurance engagements? The scope of work to be performed is not clear. Therefore, additional guidance be included by the Board.

Preliminary Knowledge of the Engagement Circumstances, Including the Scope of the Engagement

8. Is ED-5000 sufficiently clear about the practitioner's responsibility to obtain a preliminary knowledge about the sustainability information expected to be reported and the scope of the proposed assurance engagement? If not, how could the requirements be made clearer?

Overall response: Yes, with comments below

Detailed comments (if any): There should be a further guidance on defining the preliminary knowledge required by the engagement team or the mandatory engagement of an expert in the standard before accepting the engagement.

9. Does ED-5000 appropriately address the practitioner's consideration of the entity's "materiality process" to identify topics and aspects of topics to be reported? If not, what approach do you suggest and why?

Overall response: Yes, with comments below

Detailed comments (if any): We suggest the use of "process to identify reporting topics," only instead of using the three phrases interchangeably. Because this may create confusion.

Suitability and Availability of Criteria

10. Does ED-5000 appropriately address the practitioner's evaluation of the suitability and availability of the criteria used by the entity in preparing the sustainability information? If not, what do you propose and why?

Overall response: Yes (with no further comments)

11. Does ED-5000 appropriately address the notion of "double materiality" in a framework-neutral way, including how this differs from the practitioner's consideration or determination of materiality? If not, what do you propose and why?

Overall response: Yes, with comments below

Detailed comments (if any): We propose the use of "double impact". Because "double materiality" is confusing with the practitioner's determination of materiality.

Materiality

12. Do you agree with the approach in ED-5000 for the practitioner to consider materiality for qualitative disclosures and determine materiality (including performance materiality) for quantitative disclosures? If not, what do you propose and why?

Overall response: Agree, with comments below

Detailed comments (if any): Incorporating guidance on determination of materiality would still be relevant to aid practitioners and entity in performing the assurance engagement and evaluating misstatement.

Understanding the Entity's System of Internal Control

13. Do you agree with the differentiation in the approach in ED-5000 for obtaining an understanding of the entity's system of internal control for limited and reasonable assurance engagements? If not, what suggestions do you have for making the differentiation clearer and why?

Overall response: Agree, with comments below

Detailed comments (if any):

The differentiation of obtaining an understanding of certain components for limited assurance and obtaining an understanding of all components for reasonable assurance seems arbitrary. Further guidance is required to make it clearer.

Using the Work of Practitioner's Experts or Other Practitioners

14. When the practitioner decides that it is necessary to use the work of a firm other than the practitioner's firm, is ED-5000 clear about when such firm(s) and the individuals from that firm(s) are members of the engagement team, or are "another practitioner" and not members of the engagement team? If not, what suggestions do you have for making this clearer?

Groups and "Consolidated" Sustainability Information

If not, what do you propose and why?

Detailed comments (if any): It is better to have a separate ISSA or additional guidance addressing groups or "consolidated" sustainability information for subsidiaries in different jurisdictions where no equivalent standard or no equivalent regulation if their sustainability information is consolidated within the group.

Fraud

19. Do you agree that ED-5000 appropriately addresses the topic of fraud (including "greenwashing") by focusing on the susceptibility of the sustainability information to material misstatement, whether due to fraud or error? If not, what suggestions do you have for increasing the focus on fraud and why?

Earlier application would be permitted and encouraged. Do you agree that this would provide a sufficient period to support effective implementation of the ISA. If not, what do you propose and why?
