This template is for providing comments on the Exposure Draft of proposed International Standard on Sustainability Assurance Engagements[™] (ISSA) 5000, *General Requirements for Sustainability Assurance Engagements* (ED-5000), in response to the questions set out in the Explanatory Memorandum to ED-5000. Even though it can generally be applied for assurance the consolidated sustainability information of groups, we propose that the IAASB considers issuing a separate ISSA or detailed guidance addressing groups or 'consolidated' sustainability information due to wide variety of disclosure requirements and complexity involved.

The procedure requirements in general in ED-5000 are based on the ISAs framework. We believe some detailed procedures should be tailored to align more with the sustainability reporting framework. IFRS S1 requires the company to disclose information about its sustainability-related risks and opportunities that's useful for investors' decision making on the topics of governance, strategy, risk management, and metrics and targets. The sustainability report discloses a variety of sustainability information while ED-5000 provides general requirements for sustainability assurance engagements. We suggest that ED-5000 should provide more detailed guidance for the nature, timing and extent of the procedures to respond to the disclosures on strategy and opportunities, including metrics and targets.

26. Translations—Recognizing that many respondents may intend to translate the final ISSA for adoption in their own environments, the IAASB welcomes comment on potential translation issues respondents note in reviewing ED-5000.

Effective Date—As explained in paragraph 138 of Section 1-I – Other Matters, the IAASB believes that an appropriate effective date for the standard would be for assurance engagements on sustainability information reported for periods beginning or as at a specific date approximately 18 months after approval of the final standard.
