This template is for providing comments on the Exposure Draft (ED) of *Proposed International Standard on Auditing 240 (Revised), The Auditor's Responsibilities Relating to Fraud in an Audit of Financial Statements and Proposed Conforming and Consequential Amendments to Other ISAs (ED-240)*, in response to the questions set out in the Explanatory Memorandum (EM) to the ED. Detailed comments (if any): “Decoupling” key concepts highlighted in ED-240 certainly offers a clearer understanding of the auditor's responsibilities. Additionally, further clarification of the auditor's responsibilities concerning non-material fraud and suspected non-material fraud, with an extra emphasis on "qualitatively material" misstatements due to fraud, enhances the auditor's awareness beyond just materiality.
